

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Base Roll Addition)**

3 **WHEREAS, Section 1(a) of Article II of the Constitution of the Tohono O'odham Nation**
4 **provides that the Tohono O'odham Council can make additions and**
5 **changes to the official census rolls of the Sells and Gila Bend Reservations**
6 **dated January 1, 1937 and of the San Xavier Reservation dated January 1,**
7 **1940, subject to the approval of the Secretary of the Interior; and**

8 **WHEREAS, the Enrollment Committee has determined that the following named**
9 **person(s) was a member of the Tohono O'odham Nation on the date of the**
10 **respective census rolls but that their name(s) had been inadvertently**
11 **omitted therefrom, and had recommended that their name(s) be added to**
12 **the rolls; and**

13 **WHEREAS, the Tohono O'odham Council has reviewed the recommendations of the**
14 **Enrollment Committee and approves thereof.**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that, subject**
16 **to the approval of the Secretary of the Interior, the name(s) of the following**
17 **person(s) be added to the official census rolls of the Sells, Gila Bend or San**
18 **Xavier Reservation to wit:**

2009-SX-98 HUBBARD, Celestine

19 **BE IT FURTHER RESOLVED that the required approval be secured from the**
20 **Secretary of the Interior before their name(s) be formally added to such**
21 **rolls.**

23 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on**
24 **the 12TH, day of OCTOBER, 1998 at a meeting at which a quorum was present with a**
25 **vote of 1,737.0 FOR; -0- AGAINST; -0- NOT VOTING; and 190.0 [07] ABSENT, pursuant to**
26 **the powers vested in the Council by Section 1(a) of Article II and Section 1(h) of Article**
27 **VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
28 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
18, 1934 (48 Stat. 984).


