

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of the Gu-Vo District FY'98/99 Budget)**

**RESOLUTION NO. 98-432**

**WHEREAS, the Gu-Vo District Governing Council did meet on September 29, 1998 and resolved the following; and**

**WHEREAS, the Gu-Vo District Governing Council did review the proposed FY'98/99 Budget submitted by the District Administration and its four communities, with the total amount of Five Hundred Fifty-Seven Thousand Eight Hundred Seventy-One Dollars 57/100 (\$557,871.57); and**

**WHEREAS, the Gu-Vo District Governing Council did approve the budget in the following allocation:**

<b>Administration:</b>	<b>\$357,871.57</b>
<b>Gu-Vo Community</b>	<b>\$ 50,000.00</b>
<b>Ali Chugk Community</b>	<b>\$ 50,000.00</b>
<b>Pia Oik Community</b>	<b>\$ 50,000.00</b>
<b>Kukatch Community</b>	<b>\$ 50,000.00</b>

**WHEREAS, the said budgets will be modified if additional funds become available from the District FY'97/98 Budget or the Tohono O'odham Nation; and,**

**WHEREAS, the FY'97/98 Budget's remaining funds will be divided equally among the Administration and the four communities to be added to the Districts FY'98/99 Budget.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby supports and approves the Gu-Vo District FY'98/99 Budget in the amount of \$557,871.57.**

**BE IT FURTHER RESOLVED that the said amounts will be increased should additional funds become available through the FY'97/98 Budget or funds from the Tohono O'odham Nation.**
