

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Budget Modification # 1 FY 1998 State of Arizona Title IIC)**

RESOLUTION NO. 98-439

WHEREAS, the original budget for the FY 1998 State of Arizona Title IIC is in the amount of \$21,249.00; and

WHEREAS, a decrease in Capital Equipment line items have been adjusted to comply with State of Arizona regulations; and line items #610, #620, #854, #900 have been incremented to adjust for Time and cost share allocations of the Program; and

WHEREAS, the purpose of the Tohono O'odham Nation; State of Arizona-Title II-C Program is to provide training and support services to eligible Native Americans residing on the Tohono O'odham Nation; and

WHEREAS, additional line items have been included to facilitate comprehensive spending levels between cost shared budgets.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves the JTPA/NEW Budget Modification #1 for the State of Arizona Title IIC FY 1998.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials, to wit; the Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 14TH day of OCTOBER, 1998 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [08] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
