WHEREAS, for fiscal year 1998 the Tohono O'odham Police Department was appropriated Funds to address various needs of the community and the Police Department's programs; and

WHEREAS, these program improvements are in various stages of completion; and

WHEREAS, re-authorization to continue spending these project funds beyond fiscal year 1998 is required to complete the projects; and

WHEREAS, the funds appropriated in fiscal year 1998 have not been re-obligated for other purposes but remain restricted and available only for the projects for which the funds were intended for; and

WHEREAS, the Tohono O'odham Police Department requests re-authorization of fiscal year 1998 funds in the amount of \$2,251,707.00

NOW, THEREFORE, BE IT RESOLVED that the *Request for Re-Authorization for FY 98 Funds*, is hereby approved as submitted and is authorized to be expended accordingly.

BE IT FURTHER RESOLVED that the balances as identified by the attached budget are hereby re-authorized.

The foregoing Resolution was passed by the Tohono O'odham Council on the 14TH day of OCTOBER, 1998 at a meeting at which a quorum was present with a vote of 1,273.0 FOR; 654.0 AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
