RESOLUTION NO. 98-448

WHEREAS, the Judiciary Committee of the Legislative Council is currently the oversight committee regarding TERO matters; and


WHEREAS, the Chairman of the Judiciary Committee requested that the Rules Committee review and consider transferring oversight of TERO matters to the Domestic Affairs Committee; and

WHEREAS, the Rules Committee has decided that the proper oversight committee for TERO matters should be the Domestic Affairs Committee.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the oversight committee for all TERO matters is the Domestic Affairs Committee.

The foregoing Resolution was passed by the Tohono O'odham Council on the 15TH, day of October, 1998 at a meeting at which a quorum was present with a vote of 1,766.0 FOR; -0- AGAINST; -0- NOT VOTING; and 161.0 (08) ABSENT, pursuant to the powers vested in the Council by Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




