WHEREAS, Andrew Patricio of O'odham Video has agreed to a Business Lease renegotiation with the Tohono O'odham Nation for the Nation's facility in the Sells Shopping Center; and


WHEREAS, this Business Lease has been reviewed by the Tohono O'odham Legislative Council Commerce Committee; and

WHEREAS, the Business Lease has a term from October 1, 1998 through September 30, 2003, to be paid at the rate of Two Thousand Four Hundred Dollars, per year in equal monthly installments of Two Hundred Dollars, in advance on the first day of each calendar month during the entire lease term.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves the Business Lease with Andrew Patricio of O'odham Video for the term and at the rate stated above.

The foregoing Resolution was passed by the Tohono O'odham Council on the 16TH day of OCTOBER, 1998 at a meeting at which a quorum was present with a vote of 1,180.0 FOR; 747.0 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 2 (d) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


