RESOLUTION NO. 98-455

WHEREAS, the Judiciary Committee of the Tohono O'odham Legislative Council is the oversight for the Judiciary Branch; and

WHEREAS, the Judiciary Committee will be interviewing potential applicants for Judges of the Judiciary Branch; and

WHEREAS, the need for technical assistance to the Judiciary Committee is needed; and


WHEREAS, the Judiciary Committee and the Legislative Administration have agreed to contract with Goddard & Associates.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby supports the contract for \$3,500 with Goddard & Associates and the Tohono O'odham Legislative Council.

BE IT FURTHER RESOLVED that the contract amount of \$3,500 be appropriated from the Legislative Branch Budget under the Professional Services line item.

The foregoing Resolution was passed by the Tohono O'odham Council on the 16TH day of OCTOBER, 1998 at a meeting at which a quorum was present with a vote of 1,477.5 FOR; 189.5 AGAINST; 146.0 NOT VOTING; and 114.0 [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


