4 **WHEREAS, by Resolution No. 98-290 the Tohono O'odham Legislative Council**
5 **approved a proposal for intergovernmental and public relations; and**

6 **WHEREAS, included in that plan was an authorized appropriation of funds for legal**
7 **review of federal laws on campaign contributions prior to the expenditure**
8 **of any funds and during individual campaign cycles; and**

9 **WHEREAS, the Attorney General has recommended an Attorney Contract with the law**
10 **firm of Oldaker, Ryan, Phillips & Utrecht in furtherance of the**
11 **authorization of Resolution No. 98-290; and**

12 **WHEREAS, funding for the Attorney Contract is provided by the appropriation**
13 **authorized in Resolution No. 98-290 to the operating account of the**
14 **Executive Office, line item 810.**

15 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 16 **1. The Tohono O'odham Legislative Council hereby approves an**
17 **Attorney Contract with the law firm of Oldaker, Ryan, Phillips & Utrecht**
18 **in the amount of \$5,000.00 for the term October 15, 1998 through**
19 **September 30, 1999 and in the form attached hereto.**
- 20 **2. Funding for the Attorney Contract shall be provided in accordance with**
21 **Resolution No. 98-290 under the operating budget of the Executive**
22 **Office.**
- 23 **3. The Chairman of the Nation is authorized and directed to execute the**
24 **Attorney Contract.**

25 **The foregoing Resolution was passed by the Tohono O'odham Council on the 16TH day of**
26 **OCTOBER, 1998 at a meeting at which a quorum was present with a vote of 1,301.0 FOR; -0-**
27 **AGAINST; 322.0 NOT VOTING; and 304.0 [06] ABSENT, pursuant to the powers vested in the**
28 **Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation,**
adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984).


