3 **WHEREAS, pursuant to Legislative Council Resolution 97-431, the Nation entered into**
4 **an Attorney Contract with California Indian Legal Services (the "Attorneys")**
5 **for the purpose of providing legal representation to protect the Nation's**
6 **interests under the Indian Child Welfare Act in connection with legal**
7 **proceedings in the State of California; and**

9 **WHEREAS, the Attorney Contract expired on September 30, 1998; and**

10 **WHEREAS, continued representation is necessary to protect the Nation's interests in**
11 **these proceedings; and**

12 **WHEREAS, the Attorney General has recommended an extension of the Attorney**
13 **Contract for fiscal year 1999 in the amount of \$19,000; and**

14 **WHEREAS, the operating budget for the Office of Attorney General for fiscal year 1999**
15 **has sufficient funds for a Contract in such amount; and**

16 **WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative**
17 **Council of an Attorney Contract with the Attorneys on such terms.**
