

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract with Law Firm of Williams, Janov & Cooney)**

3 **WHEREAS, by Resolution 97-433 the Tohono O'odham Legislative Council approved an**
4 **Attorney Contract with the law firm of Williams & Janov, now known as**
5 **Williams, Janov & Cooney (the "Attorneys"), to provide legal representation**
6 **with respect to certain of the Nation's water matters; and**

7 **WHEREAS, the Attorney Contract expired on September 30, 1998; and**

8 **WHEREAS, continued representation regarding water matters is required to protect**
9 **the Nation's interests; and**

10 **WHEREAS, the Attorney General has recommended an extension of the Attorney**
11 **Contract for fiscal year 1999 in the amount of \$10,000; and**

12 **WHEREAS, the operating budget of the Office of Attorney General for fiscal year 1999**
13 **includes sufficient funding for the Contract; and**

14 **WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative**
15 **Council of an Attorney Contract with the Attorneys on such terms.**

16 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 17 **1. The Tohono O'odham Legislative Council hereby approves an Attorney**
18 **Contract with the law firm of Williams, Janov & Cooney in the amount**
19 **of \$10,000 for the fiscal year ending September 30, 1999 and in the form**
20 **attached hereto.**
- 21 **2. Funding for the Attorney Contract shall be provided under the**
22 **operating budget of the Office of Attorney General for fiscal year 1999.**
- 23 **3. The Chairman of the Nation is authorized and directed to execute the**
24 **Attorney Contract.**

25 **The foregoing Resolution was passed by the Tohono O'odham Council on the 03RD, day**
26 **of NOVEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,785.0**
27 **FOR; -0- AGAINST; 142.0 NOT VOTING; and [03] ABSENT, pursuant to the powers vested**
28 **in the Council by Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham**
Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by
the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
