

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract with Law Firm of Rothstein, Donatelli,
Hughes, Dahlstrom, Cron & Schoenburg)**

RESOLUTION NO. 98-466

WHEREAS, by Resolution 97-436 the Tohono O'odham Legislative Council approved an Attorney Contract with the law firm of Rothstein, Donatelli, Hughes, Dahlstrom, Cron & Schoenburg (the "Attorneys") to provide legal representation with respect to certain of the Nation's gaming matters; and

WHEREAS, the Attorney Contract expired on September 30, 1998; and

WHEREAS, continued representation regarding gaming matters is required to protect the Nation's interests; and

WHEREAS, the Attorney General has recommended an extension of the Attorney Contract for fiscal year 1999 in the amount of \$5,000; and

WHEREAS, the operating budget of the Office of Attorney General for fiscal year 1999 includes sufficient funding for the Contract; and

WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of an Attorney Contract with the Attorneys on such terms.

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Tohono O'odham Legislative Council hereby approves an Attorney Contract with the law firm of Rothstein, Donatelli, Hughes, Dahlstrom, Cron & Schoenburg in the amount of \$5,000 for the fiscal year ending September 30, 1999 and in the form attached hereto.**
- 2. Funding for the Attorney Contract shall be provided under the operating budget of the Office of Attorney General for fiscal year 1999.**
- 3. The Chairman of the Nation is authorized and directed to execute the Attorney Contract.**

The foregoing Resolution was passed by the Tohono O'odham Council on the 03RD. day of NOVEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




