## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Approving Attorney Contract with Law Firm of Rothstein, Donatelli, Hughes, Dahlstrom, Cron & Schoenburg)

1 2 **RESOLUTION NO. 98-466** 3 WHEREAS, by Resolution 97-436 the Tohono O'odham Legislative Council approved an 4 Attorney Contract with the law firm of Rothstein, Donatelli, Hughes, 5 Dahlstrom, Cron & Schoenburg (the "Attorneys") to provide legal 6 representation with respect to certain of the Nation's gaming matters; and 7 WHEREAS, the Attorney Contract expired on September 30, 1998; and 8 WHEREAS, continued representation regarding gaming matters is required to protect 9 the Nation's interests: and 10 WHEREAS, the Attorney General has recommended an extension of the Attorney 11 Contract for fiscal year 1999 in the amount of \$5,000; and 12 WHEREAS, the operating budget of the Office of Attorney General for fiscal year 1999 13 includes sufficient funding for the Contract; and 14 WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative 15 Council of an Attorney Contract with the Attorneys on such terms. 16 NOW, THEREFORE, BE IT RESOLVED THAT: 17 The Tohono O'odham Legislative Council hereby approves an Attorney 18 Contract with the law firm of Rothstein, Donatelli, Hughes, Dahlstrom, 19 Cron & Schoenburg in the amount of \$5,000 for the fiscal year ending 20 September 30, 1999 and in the form attached hereto. 21 2. Funding for the Attorney Contract shall be provided under the 22 operating budget of the Office of Attorney General for fiscal year 1999. 23 The Chairman of the Nation is authorized and directed to execute the 24 **Attorney Contract.** 25 The foregoing Resolution was passed by the Tohono O'odham Council on the <u>03RD</u>. day of NOVEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; 26 -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to 28

Section 16 of the Act of June 18, 1934 (48 Stat. 984).
