15		(Account No. 01-1809-810) was approved for fiscal year 1998 for legal costs
16		associated with implementation of the Initiative; and
17	WHEREAS,	pending approval of the Budget for fiscal year 1999, by Resolution 98-404
18		the Legislative Council authorized continuing expenditures at the rate
19 20		approved in the fiscal year 1998 Budget for a period of 90 days commencing
21		October 1, 1998; and
22	WHEREAS,	in accordance with Resolution 98-404, the Attorney General has
2 3		recommended an extension of the Attorney Contract for fiscal quarter
24		ending December 31, 1998 in the amount of \$12,500; and
2 5	WHEREAS,	the Domestic Affairs Committee recommends approval by the Legislative
