3 **WHEREAS, the San Lucy District Council adopted Resolution SL 09-71-98, which**
4 **permitted continuing operations of the District until such time that a**
5 **comprehensive FY-99 budget is adopted by the San Lucy District Council**
6 **and approved by the Tohono O'odham Legislative Council; and**

8 **WHEREAS, the Tohono O'odham Legislative Council Resolution 98-415 did approve for**
9 **San Lucy District to continue operations under their FY 1998 Budget; and**

10 **WHEREAS, the District Council has prepared and approved their proposed FY 1999**
11 **District Budget in the amount of \$1,870,269.41 to cover anticipated cost and**
12 **expenses from October 01, 1998 to September 30, 1999; and**

13 **WHEREAS, funds in the amount of \$41,600.00 will be available from 93-638 Substance**
14 **Abuse Contract to cover expenses related to the District's Drug and Alcohol**
15 **Project.**

16 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**
17 **hereby approves the San Lucy District FY 1999 Budget in the amount of**
18 **\$1,870,269.41 to commence retro active October 01, 1998 and ending on**
19 **September 30, 1999.**

20 **BE IT FURTHER RESOLVED that the San Lucy District has sufficient funds in the District's**
21 **Gaming Revenue Account to provide for the proposed governmental**
22 **operations in the amount of \$457,038.64 and P.L. 99-503 funds to provide**
23 **additional administrative, support, and program operations contained in**
24 **the FY-99 budget, in the amount of \$1,371,630.77.**


25 **BE IT FINALLY RESOLVED that bi-weekly disbursements will be wire transferred to**
26 **Account No. 8221861432, Community First Gila Bend Branch, Gila Bend,**
27 **Arizona.**


