2 RESOLUTION NO. 98-478 3 WHEREAS, on June 28, 1997 the voters of the Tohono O'odham Nation (the "Nation") 4 approved Initiative No. IN-01-97 (the "Initiative"); and 5 WHEREAS, the Initiative authorized funding from Gaming Revenues for several 6 measures, including a one-time per capita distribution of \$2,000 to each 7 member of the Nation enrolled on June 28, 1997 (the "Initial Per Capita 8 Distribution"); and 9 WHEREAS. pursuant to Resolution 97-451, the Legislative Council adopted an 10 Initiative Funding and Implementation Plan (the "FIP") which authorized 11 the establishment of set-aside accounts for the Initial Per Capita 12 Distribution and other Initiative measures, and set certain conditions on 13 the expenditure of funds from such accounts; and 14 WHEREAS. by Resolution 97-478, the Legislative Council approved the transfer of 15 funds from the Desert Diamond Savings Account to certain designated set-16 17 aside accounts established at Bank of America Arizona, including the sum 18 of \$41.5 million to set-aside account no. 3030425-1067524 for the Initial 19 Per Capita Distribution (the "Per Capita Account"); and 20 WHEREAS, three of the conditions to expenditure of the Per Capita Account specified 21 in the FIP are (1) approval by the Secretary of the Interior of a per capita 22 distribution plan (the "Revenue Allocation Plan") pursuant to the **2**3 requirements of the Indian Gaming Regulatory Act, 25 U.S.C. § 2710 (b) (3); 24 (2) acceptance by the Legislative Council of a Certification of Eligible 25 Members submitted by the Enrollment Office and based upon receipt of **26** a properly completed and filed Certificate of Eligibility Verification for Per 27 Capita Payment for each member; and (3) as to each Minor Eligible 28 Member, establishment of a restricted account at Bank of America for

approves the Certification of Eligible Members, in the form attached

- The Legislative Council authorizes (a) the transfer of the sum of \$74,000 from the Per Capita Account to the special checking account no. 252-350-324 established at Bank of America Arizona (the "Per Capita Checking Account"); and (b) upon the joint signature of the Chairman and Vice Chairman of the Nation, issuance of a check on the Per Capita Checking Account in the amount of (i) \$2,000 to each Eligible Member residing in the United States and listed in the attached Certification of Eligible Members and (ii) \$1,400 to each Eligible Member residing outside the United States and listed in the attached Certification, with the balance of \$600 withheld and remitted to the Internal Revenue Service pursuant to the requirements of federal law.
- The Chairman of the Nation is authorized to execute such other documents as may be necessary to implement this Resolution.

The foregoing Resolution was passed by the Tohono O'odham Council on the <u>04TH.</u> day of NOVEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,450,0 FOR; <u>-0-</u> AGAINST; <u>-0-</u> NOT VOTING; and <u>477.0 [08]</u> ABSENT, pursuant to the powers vested in the Council by Section 1(d)(1). (2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on 23||March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
