

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Correcting Typographical Errors in Resolution No. 98-431)**

**RESOLUTION NO. 98-479**

**WHEREAS, Tohono O'odham Legislative Council Resolution No. 98-431 was passed on  
October 12, 1998 but contained several typographical errors; and  
WHEREAS, "57" on page 2, line 23 should have "56"; and  
WHEREAS, "\$114,000" on page 3, line 8 should have read "\$112,000"; and  
WHEREAS, the Tohono O'odham Legislative Council desires to correct the  
typographical errors.**

**NOW, THEREFORE, BE IT RESOLVED THAT:**

- 1. Resolution No. 98-431 is amended as follows;**
- 2. "57" on page 2, line 23 is deleted and replaced with "56"; and**
- 3. "\$114,000" on page 3, line 8 is deleted and replaced with "\$112,000".**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 04TH, day of  
NOVEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,435.0 FOR;  
-0- AGAINST; 161.0 NOT VOTING; and 331.0 [07] ABSENT, pursuant to the powers vested in  
the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation,  
adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting  
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to  
Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
