1 2 **RESOLUTION NO. 98-480** 3 WHEREAS, Article II § 2 (A) (1) of ORDINANCE NO. 5-81 as amended (the Enrollment 4 Ordinance) requires that the Enrollment Committee receive and review all 5 membership applications for enrollment in the Nation and make 6 recommendations to the Council whether such applications should be 7 approved or rejected; and 8 WHEREAS, Article II § 2 (A) (2) of the Enrollment Ordinance requires that the 9 Enrollment Committee receive and review all applications for adoption 10 into membership of the Nation and make recommendations to the Council 11 whether such applications should be approved or rejected; and 12 WHEREAS, the Enrollment Committee has reviewed applications for enrollment or 13 adoption and is recommending to the Council that such applications be 14 rejected; and 15 WHEREAS, Article VIII § 1 (B) of the Enrollment Ordinance requires that "Before 16 making a final determination that an application for enrollment or 17 adoption should be rejected, the Council shall hold a hearing concerning 18 the applicant's eligibility for enrollment or adoption; and 19 WHEREAS, the Enrollment Committee requests that the Council schedule 20 hearings 20 of which 5 are consolidated for final determination of eligibility for 21 enrollment or adoption. 22 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that: **2**3 1. Eight hearings for Final Determination of Eligibility for Enrollment or 24 Adoption are scheduled for January 20, 1999 at the Council Chambers 25 in Sells, Arizona; and 26 Twelve hearings for Final Determination of Eligibility for Enrollment or Adoption are scheduled for January 21, 1999 at the Council 27 Chambers in Sells, Arizona. 28
