4 **WHEREAS, Article II § 2 (A) (1) of ORDINANCE NO. 5-81 as amended (the Enrollment**
5 **Ordinance) requires that the Enrollment Committee receive and review all**
6 **membership applications for enrollment in the Nation and make**
7 **recommendations to the Council whether such applications should be**
8 **approved or rejected; and**

9 **WHEREAS, Article II § 2 (A) (2) of the Enrollment Ordinance requires that the**
10 **Enrollment Committee receive and review all applications for adoption**
11 **into membership of the Nation and make recommendations to the Council**
12 **whether such applications should be approved or rejected; and**

13 **WHEREAS, the Enrollment Committee has reviewed applications for enrollment or**
14 **adoption and is recommending to the Council that such applications be**
15 **rejected; and**

16 **WHEREAS, Article VIII § 1 (B) of the Enrollment Ordinance requires that "Before**
17 **making a final determination that an application for enrollment or**
18 **adoption should be rejected, the Council shall hold a hearing concerning**
19 **the applicant's eligibility for enrollment or adoption; and**

20 **WHEREAS, the Enrollment Committee requests that the Council schedule 20 hearings**
21 **of which 5 are consolidated for final determination of eligibility for**
22 **enrollment or adoption.**

23 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 24 **1. Eight hearings for Final Determination of Eligibility for Enrollment or**
25 **Adoption are scheduled for January 20, 1999 at the Council Chambers**
26 **in Sells, Arizona; and**
- 27 **2. Twelve hearings for Final Determination of Eligibility for Enrollment**
28 **or Adoption are scheduled for January 21, 1999 at the Council**
Chambers in Sells, Arizona.




