

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Schuk Toak District FY-1999 Budget)**

3 **WHEREAS, the Schuk Toak District Council did convene in a meeting held on October**  
4 **22, 1998 at which a quorum was present; and**

5 **WHEREAS, the Schuk Toak District by Resolution #ST-09-16-98-63 and Tohono**  
6 **O'odham Legislative Council Resolution No. 98-408 did extend their FY-98**  
7 **budget until the FY-99 budget has been approved; and**

8 **WHEREAS, the Schuk Toak District Council did review the proposed budget and**  
9 **activities for FY-99; and**

10 **WHEREAS, the Schuk Toak District will be utilizing the Gaming Revenues that was**  
11 **made available to the District in the amount of \$557,871.57; and**

12 **WHEREAS, the Schuk Toak District FY-99 budget will commence upon approval and**  
13 **end on September 30, 1999; and**

14 **WHEREAS, the Schuk Toak District did present their FY-99 budget as approved by the**  
15 **Schuk Toak District Council by Resolution #ST-10-22-98-64 to the Tohono**  
16 **O'odham Legislative Council for approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council**  
18 **does hereby approve the FY-99 budget for Schuk Toak District in the**  
19 **amount of \$557,871.57 and that modifications to said budget can be made**  
20 **as necessary.**

21 **The foregoing Resolution was passed by the Tohono O'odham Council on the 05TH day**  
22 **of NOVEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,785.0 FOR;**  
23 **-0- AGAINST; -0- NOT VOTING; and 142.0 [03] ABSENT, pursuant to the powers vested in the**  
24 **Council by Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation,**  
**adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**  
**Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**  
**Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
