1 2 **RESOLUTION NO. 98-488** 3 the Pisinemo District did present an amendment to their FY-99 Budget to WHEREAS. 4 the Tohono O'odham Legislative Council at a regularly scheduled meeting 5 held November 05, 1998 to increase wages for the ten District workers; and 6 WHEREAS, the Tohono O'odham Legislative Council did determine that the Pisinemo 7 District does have sufficient funds available in the annual Gaming Revenue 8 disbursement received for FY-99 to increase the salaries and fringe benefits 9 of the District Workers to \$7.00 an hour with a retroactive payment to 10 October 01, 1998; and 11 WHEREAS, the Pisinemo District did approve this amendment through Pisinemo 12 District Council Resolution No. 98-14 on October 26, 1998. 13 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council 14 does approve the amendment for Pisinemo District FY-99 budget for an 15 increase from \$669,449.00 to \$703,747.00 for salary and fringe benefit 16 17 increase for the ten Pisinemo District Workers to \$7.00 per hour with retroactive payment to October 01, 1998. 18 19 BE IT FURTHER RESOLVED that the Pisinemo District will transfer \$34,298.00 from **20** District account #235642739 of the District's Gaming Revenue 21 Disbursement Savings to the Pisinemo Business Money Market Account 22 #235267027 in the Tohono O'odham Nation's Accounting Department to **2**3 cover costs for the salary and fringe benefit increase. 24 The foregoing Resolution was passed by the Tohono O'odham Council on the 05TH. day of NOVEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,785.0 **2**5 FOR; -0- AGAINST; -0- NOT VOTING; and 142.0 [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham **26** Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant 27

to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
