

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 1998 Community Health Services/HIV Prevention and
Control Services Budget)**

RESOLUTION NO. 98-495

WHEREAS, the Tohono O'odham Nation has operated the Human Immunodeficiency Virus (HIV) Prevention and Control Services Program to provide HIV/STD prevention education to communities and schools; and

WHEREAS, funding for the prevention education has been provided by the Arizona Department of Health Services for Human Immunodeficiency Virus (HIV) Prevention and Control Services in the amount of \$7,000.00; and

WHEREAS, the Tohono O'odham Nation does desire to continue to provide HIV/STD prevention education to communities and schools; and

WHEREAS a budget in the amount of \$7,000.00 is submitted for review and approval by the Department of Human Services, Division of Community Health Services to utilize funds for prevention education.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:

- 1. It hereby approves the attached budget submitted by Community Health Services.**
- 2. The Tohono O'odham Nation's Officials to wit: the Chairman and Vice Chairman and any designated Official are hereby authorized to negotiate and execute contracts associated with this grant and to expend funds when received.**

The foregoing Resolution was passed by the Tohono O'odham Council on the 07TH, day of DECEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
