3 **WHEREAS, the Tohono O'odham Department of Health and Human Services was**  
4 **approved for a grant to establish the Community Based Diabetes**  
5 **Prevention Program under the Special Diabetes Program for Indians,**  
6 **authorized by the Balanced Budget Act; and**

7 **WHEREAS, monies were set aside from the Special Diabetes Program for Indians for**  
8 **Data Improvement on Diabetes; and**

9 **WHEREAS, the Tohono O'odham Legislative Council through Resolution No.98-150**  
10 **established and approved a budget for the Data Improvement Grant**  
11 **\$116,000; and**

12 **WHEREAS the monies were not distributed until June, 1998 and the fiscal year ending**  
13 **September, 1998; and**

14 **WHEREAS, monies for fiscal year 1998 budget will be extended from June 01, 1998 to**  
15 **May 31, 1999; and**

16 **WHEREAS, a budget is resubmitted for review and approved by the Department of**  
17 **Human Services for \$116,000.00 for Data Improvement.**

18 **NOW, THEREFORE, BE IT RESOLVED,**

- 19           **1. That the Tohono O'odham Legislative Council hereby approves the**  
20           **attached budget in the amount of \$116,000.00 for Data Improvement.**  
21           **2. The Tohono O'odham Nation officials, to wit: the Chairman and Vice**  
22           **Chairman or designated official are hereby authorized to negotiate**  
23           **and execute the contract and expend funds when received.**

24 **The foregoing Resolution was passed by the Tohono O'odham Council on the 07TH. day of**  
25 **DECEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,927.0 FOR;**  
26 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the**  
27 **Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation,**  
28 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**  
**Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**  
**Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
