

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'odham Department of Human Services - Division of Child Welfare
Services - FY '99 Project 2000 Base Budget Modification #1)**

RESOLUTION NO. 98-498

**WHEREAS, the Tohono O'odham Nation is presently operating the Project 2000 under
a Tribal Base Budget; and**

**WHEREAS, the budget modification is necessary to implement a reclassification of a
Parent Aide position to Child Welfare Specialist; and**

**WHEREAS, a budget modification has been submitted which does not change the
funding level, but includes the reclassification position and modifies other
line item amounts to address current need.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council
that implementation of this Child Welfare Specialist position be part of the
future base budget; and hereby approves the amendment to the Project
2000 and authorize expenditures in accordance with the attached budget
modification.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 07TH day of
DECEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,846.5 FOR;
80.5 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the
Council by Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation,
adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


