(Approval of FY 1998 Department of Human Services/Division of Community
Health Services - Elder Health Care Initiative Budget Modification #3)**

RESOLUTION NO. 98-499

WHEREAS, the Tohono O'odham Nation is presently developing a Home Health Agency under IHS Grant #ISH002103-02 with the Indian Health Services; and

WHEREAS, Legislative Council, through Resolution No. 97-265, approved a five-year project and year one budget in the amount of \$180,994.00; and

WHEREAS, the Department of Health and Human Services, Public Health Service, Indian Health Service Notice of Grant Award dated August 26, 1997 authorized a Year 1 Total approved budget in the amount of \$179,213.00.

NOW, THEREFORE, BE IT RESOLVED:

- 1. It hereby approves the Elder Health Care Initiative Budget Modification #3 as submitted for FY 1998.**

The foregoing Resolution was passed by the Tohono O'odham Council on the 07TH day of DECEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,856.0 FOR; -0- AGAINST; 71.0 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
