

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 1999 Department of Human Services/Division of Community
Health Services - Elder Health Care Initiative Budget Modification #2)**

RESOLUTION NO. 98-500

WHEREAS, the Tohono O'odham Nation is presently developing a Home Health Agency under IHS Grant #ISH002103-02 with the Indian Health Services; and

WHEREAS, the Legislative Council, through Resolution No. 97-265, approved a five-year project and year two budget in the amount of \$189,050.00; and

WHEREAS, there is a continued need for a coordinated, comprehensive delivery of basic services to frail and disabled elders in their home on the Tohono O'odham Nation; and

WHEREAS, a budget modification is submitted for review to continue the development of a Home Health Agency and to provide educational material promoting prevention of health problems, for both elders and care givers.

NOW, THEREFORE, BE IT RESOLVED:

- 1. It hereby approves the authorization for use of Elder Health Care Initiative Project Year 1 (FY98) carry over funds in Project Year 2 (FY99).**
- 2. It hereby approves the Elder Health Care Initiative, Budget Modification #2 as submitted.**
- 3. The Tohono O'odham Nation Officials, to wit: the Chairman and Vice Chairman and any designated Official is hereby authorized to negotiate and execute contracts associated with this grant and to expend funds when received.**

The foregoing Resolution was passed by the Tohono O'odham Council on the 07TH. day of DECEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [0] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
