1 2 RESOLUTION NO. 98-500 3 WHEREAS, the Tohono O'odham Nation is presently developing a Home Health Agency 4 5 under IHS Grant #ISH002103-02 with the Indian Health Services; and 6 WHEREAS, the Legislative Council, through Resolution No. 97-265, approved a five-7 year project and year two budget in the amount of \$189,050.00; and 8 WHEREAS, there is a continued need for a coordinated, comprehensive delivery of 9 basic services to frail and disabled elders in their home on the Tohono 10 O'odham Nation; and 11 WHEREAS, a budget modification is submitted for review to continue the development 12 of a Home Health Agency and to provide educational material promoting 13 prevention of health problems, for both elders and care givers. 14 NOW, THEREFORE, BE IT RESOLVED: 15 1. It hereby approves the authorization for use of Elder Health Care 16 Initiative Project Year 1 (FY98) carry over funds in Project Year 2 (FY99). 17 2. It hereby approves the Elder Health Care Initiative, Budget 18 19 Modification #2 as submitted. 20 The Tohono O'odham Nation Officials, to wit: the Chairman and Vice 21 Chairman and any designated Official is hereby authorized to 22 negotiate and execute contracts associated with this grant and to **2**3 expend funds when received. 24 The foregoing Resolution was passed by the Tohono O'odham Council on the <u>07TH.</u> day of DECEMBER, 1998 at a meeting at which a quorum was present with a vote of 1.927.0 FOR; **2**5 <u>-0- AGAINST; -0- NOT VOTING; and [0] ABSENT, pursuant to the powers vested in the Council</u> by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by 26 the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 27

of the Act of June 18, 1934 (48 Stat. 984).
