

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Application for Southwestern Foundation Grant Proposal
in Support of Site Analysis Studies of Proposed Cultural Center/Museum
Site for the Tohono O'odham Nation)**

RESOLUTION NO. 98-502

WHEREAS, the O'odham have been present in identified Papageria which has been the traditional and aboriginal territory of the O'odham since time immemorial; and

WHEREAS, the O'odham have engaged in Traditional Cultural Activities in the identified Papageria for thousands of years; and

WHEREAS, the O'odham have numerous Traditional, Natural, Cultural and Religious resources throughout the known Papageria; and

WHEREAS, the Tohono O'odham Nation has established a Cultural Affairs Office and hired staff for the office in order to preserve, protect and manage the Cultural Resources of the Nation; and

WHEREAS part of the work done by the Cultural Affairs Office involves working with the Cultural Center/Museum Committee to plan for a Cultural Center/Museum for the Nation; and

WHEREAS, the Cultural Affairs Office is applying for a grant from the Southwestern Foundation to fund site analysis studies for three proposed Cultural Center/ Museum sites.

NOW, THEREFORE BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes and approves this resolution that permits the Cultural Affairs Office to submit the attached grant proposal to the Southwestern Foundation.

The foregoing Resolution was passed by the Tohono O'odham Council on the 07TH. day of DECEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by Section 1 (c)(8) & (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
