1 2 **RESOLUTION NO. <u>98-505</u>** 3 on June 28, 1997 the voters of the Tohono O'odham Nation (the "Nation") WHEREAS. 4 approved Initiative No. IN-01-97 (the "Initiative"); and 5 WHEREAS, the Initiative authorized funding from Gaming Revenues for several 6 measures, including a one-time per capita distribution of \$2,000 to each 7 member of the Nation enrolled on June 28, 1997 (the "Initial Per Capita 8 Distribution"); and 9 10 WHEREAS. pursuant to Resolution 97-451, the Legislative Council adopted an 11 Initiative Funding and Implementation Plan (the "FIP") which authorized 12 the establishment of set-aside accounts for the Initial Per Capita 13 Distribution and other Initiative measures, and set certain conditions on 14 the expenditure of funds from such accounts; and 15 WHEREAS. by Resolution 97-478, the Legislative Council approved the transfer of 16 funds from the Desert Diamond Savings Account to certain designated set-17 aside accounts established at Bank of America Arizona, including the sum 18 of \$41.5 million to set-aside account no. 3030425-1067524 for the Initial 19 Per Capita Distribution (the "Per Capita Account"); and 20 WHEREAS. three of the conditions to expenditure of the Per Capita Account specified 21 in the FIP are (1) approval by the Secretary of the Interior of a per capita 22 distribution plan (the "Revenue Allocation Plan") pursuant to the 23 requirements of the Indian Gaming Regulatory Act, 25 U.S.C. § 2710 (b) (3); 24 (2) acceptance by the Legislative Council of a Certification of Eligible **25** Members submitted by the Enrollment Office and based upon receipt of 26 a properly completed and filed Certificate of Eligibility Verification for Per 27 Capita Payment for each member; and (3) as to each Minor Eligible 28 Member, establishment of a restricted account at Bank of America for

RESOLUTION NO. <u>98-505</u> (Accepting Certification of Eligible Members and Authorizing the Initial Expenditure of Funds for Per Capita Payments under the Initiative) 1 Page 2 of 4 2 deposit of such member's per capita payment; and 3 pursuant to Resolution 97-452, the Legislative Council adopted a Revenue WHEREAS. 4 Allocation Plan and caused the Plan to be submitted for approval by the 5 Phoenix Area Office of the Bureau of Indian Affairs in accordance with 6 authority delegated to the Area Office by the Secretary of the Interior; and 7 WHEREAS, by letter dated December 18, 1997, the Area Office approved the Revenue 8 Allocation Plan with respect to the Initial Per Capita Distribution and 9 disapproved the Plan with respect to the Biennial Per Capita Payments; 10 and 11 WHEREAS, an agreement with Bank of America has not yet been finalized for the 12 establishment of the restricted accounts which is required as a condition 13 to disbursement of the Initial Per Capita Distribution to such accounts for 14 Minor Eligible Members; and 15 WHEREAS, pursuant to Resolution Nos. 97-525, 98-010, 98-037, 98-084, 98-192, 98-207, 16 98-278, 98-316, 98-360, 98-431, and 98-478 the Legislative Council accepted 17 and approved Certifications of Eligible Members for the Initial Per Capita 18 Distribution, and disbursements have been made to such members; and 19 WHEREAS, the Enrollment Office has filed with the Legislative Council a Certification 20 of Eligible Members listing 66 adult members who are eligible for receipt 21 of the Initial Per Capita Distribution; and 22 WHEREAS, all conditions under the laws of the United States and the Nation have been satisfied to permit the disbursement of the Initial Per Capita 24 Distribution to the members listed in the Certification of Eligible 25 members. 26 NOW, THEREFORE, BE IT RESOLVED THAT: 27 28 The Tohono O'odham Legislative Council hereby accepts and RESOLUTION NO. 98-505

- 2. The Legislative Council authorizes (a) the transfer of the sum of \$132,000 from the Per Capita Account to the special checking account no. 252-350-324 established at Bank of America Arizona (the "Per Capita Checking Account"); and (b) upon the joint signature of the Chairman and Vice Chairman of the Nation, issuance of a check on the Per Capita Checking Account in the amount of (i) \$2,000 to each Eligible Member residing in the United States and listed in the attached Certification of Eligible Members and (ii) \$1,400 to each Eligible Member residing outside the United States and listed in the attached Certification, with the balance of \$600 withheld and remitted to the Internal Revenue Service pursuant to the requirements of federal law.
- 3. The Chairman of the Nation is authorized to execute such other documents as may be necessary to implement this Resolution .

The foregoing Resolution was passed by the Tohono O'odham Council on the <u>08TH</u>. day of <u>DECEMBER</u>, <u>1998</u> at a meeting at which a quorum was present with a vote of <u>1.785.0</u> FOR; <u>-0</u>- AGAINST; <u>-0</u>- NOT VOTING; and <u>142.0 [04]</u> ABSENT, pursuant to the powers vested in the Council by Section <u>1(d)(1)</u>. (2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
