**WHEREAS, the Tohono O'Odham Nation has present and anticipated equipment and general services needs during the balance of Fiscal Year 1999; and**


**WHEREAS, the Budget and Finance Committee of the Legislative Council has reviewed Addendum No. 3 and recommends approval.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council approves Addendum No. 3 between Lucent Technologies, Inc., and the Tohono O'Odham Nation.**

**BE IT FURTHER RESOLVED that the Legislative Council authorizes the Chairman of the Tohono O'Odham Nation and the Chairman of the Legislative Council to sign the Addendum.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 08TH. day of DECEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,358.0 FOR; -0- AGAINST; -0- NOT VOTING; and 569.0 [13] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




