

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Choulic Community/Baboquivari District FY-99 Budget  
Amendment/Modification)**

**RESOLUTION NO. 98-515**

**WHEREAS, by Resolution 98-413 the Tohono O'odham Legislative Council approved the Baboquivari District FY-99 budget; and**

**WHEREAS, any change in the justification or funding levels need Tohono O'odham Legislative Council review and approval; and**

**WHEREAS, by Resolution 98-B-174 the Baboquivari District Council approved an amendment and modification for Choulic Community; and**

**WHEREAS, the Tohono O'odham Legislative Council was presented with Choulic community's budget modification along with the creation of new line item 771: Repair Maintenance Vehicle in the amount of one thousand dollars and no cents (\$1,000.00).**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves the Choulic community/Baboquivari District budget amendment and modification in the amount of one thousand dollars and no cents (\$1,000.00).**

**BE IT FURTHER RESOLVED that a new line item be added to Choulic community's/ Baboquivari District FY-99 budget.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 08TH, day of DECEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,358.0 FOR; -0- AGAINST; -0- NOT VOTING; and 569.0 [13] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
