

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Re-Authorizing Funds for Initiative Administrative Costs)**

RESOLUTION NO. 98-518

WHEREAS, the Legislative Council of the Tohono O'odham Nation set aside funds as Administrative Costs for the implementation of initiative IN-01-97 in Resolution 97-451; and

WHEREAS, the Legislative Council, by means of Resolution 98-064, authorized expenditure of the Administrative cost set-aside and appropriated a Fiscal Year 1998 budget for the Economic Development Department; and

WHEREAS, Resolution 98-604 authorized and appropriated the sum of \$75,000 for the purpose of construction and building modification to provide office and program space for new staff and their activities; and

WHEREAS, time did not permit expenditure of this appropriation before the end of fiscal Year 1998; and

WHEREAS, the need for the building modification still exists.

NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the Tohono O'odham Nation that a Fiscal Year 1999 budget of \$75,000 is authorized for the purpose of construction and building modification to provide office and program space for the Economic Development Department.

BE IT FURTHER RESOLVED that \$75,000 is appropriated from the Initiative Administrative Cost set-aside in support of this budget.

The foregoing Resolution was passed by the Tohono O'odham Council on the 09TH. day of DECEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,737.0 FOR; -0- AGAINST; -0- NOT VOTING; and 190.0 [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
