hereby supports the request of Artincia Liston and appropriates the  
amount of \$1,350.00 to cover expenses.**

**BE IT FURTHER RESOLVED that the amount of \$1,350.00 shall be appropriated from the  
General Revenue.**

Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by  
the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,  
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
