RESOLUTION NO. 98-524

WHEREAS, by Resolution No. 97-309, the Tohono O'odham Nation retained Crawford Computer Consulting to provide professional services to develop the database data entry forms and reports for the Tohono O'odham Nation Population and Housing Survey; and

WHEREAS, the Tohono O'odham Nation Population and Housing Survey has been completed and survey results are in draft forms; and

WHEREAS, survey results have been reviewed by the Tohono O'odham Legislative Housing Committee and determined that additional work is necessary to finalize the draft survey results prior to its presentation and release; and

WHEREAS, corrections to data entries and modification of the existing database data entry format necessitate the services of Crawford Computer Consulting; and

WHEREAS, Tohono O'odham Legislative Housing Committee is recommending approval of the proposed contract by the Tohono O'odham Legislative Council.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves the professional services contract between the Tohono O'odham Nation and Crawford Computer Consulting in the amount of \$750.00.

BE IT FURTHER RESOLVED that compensation for services to be performed will be from the FY 1999 Legislative Branch budget.

BE IT FINALLY RESOLVED that the Chairman of the Nation and the Chairman of the Tohono O'odham Legislative Council are authorized to execute the contract.
