4 **WHEREAS, the Legislative Council believes that all employees of the Tohono O'odham**  
5 **Nation's three government branches, including employees of the Tohono**  
6 **O'odham Ki:ki and elected officials from the Legislative and Executive**  
7 **branches each receive a Christmas bonus; and**

8 **WHEREAS, the Legislative Council had decided that the amount of \$700.00, be given to**  
9 **each employee without tax deductions; and**

10 **WHEREAS, the total number of employees and elected officials that will be granted the**  
11 **bonus and the amounts are as follows:**

approve and appropriate a total amount of \$1,198,765.43 from the  
estimated 1998 savings to provide for Christmas Bonus payments.

DECEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,225.0 FOR;  
556.0 AGAINST; 146.0 NOT VOTING; and [08] ABSENT, pursuant to the powers vested in the  
Council by Section 1(d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation,  
adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting  
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to  
Section 16 of the Act of June 18, 1934 (48 Stat. 984).
