1 2 **RESOLUTION NO. 98-530** 3 WHEREAS. the Legislative Council did address vetoed Resolution No. 98-526 at the 4 December 15, 1998 Special Session; and 5 WHEREAS. an attempt to override vetoed Resolution No. 98-526 failed; and 6 WHEREAS. corrections to errors in Resolution No. 98-504 was necessary to cover all 7 employees of the Nation and also to include twelve (12) Senior Community 8 Services Employment Program workers. 9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council 10 hereby approves the amendment to Resolution No. 98-504. 11 BE IT FURTHER RESOLVED that the amount appropriated in Resolution No. 98-12 504, (\$780,584.24) for Christmas Bonus payments is hereby increased to 13 include additional employees for a final total amount of \$822,221.83. 14 BE IT FINALLY RESOLVED that the source of funding identified is the FY 1998 savings. 15 The foregoing Resolution was passed by the Tohono O'odham Council on the 15TH, day of 16 DECEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,290.5 FOR: 499.0 AGAINST; 137.5 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the 17 Council by Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting 18 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to 19 Section 16 of the Act of June 18, 1934 (48 Stat. 984). 20 TOHONO O'ODHAM LEGISLATIVE COUNCIL 21 22 Dennis Ramon, Legislative Chairman 23 24 ATTEST: 25 26 ulianna Saraficio, Acting Legislative Secretary 28
