

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Resolution No. 98-504, "Approving Christmas Bonus Payments  
to the Nation's Employees")**

4 **WHEREAS, the Legislative Council did address vetoed Resolution No. 98-526 at the**  
5 **December 15, 1998 Special Session; and**

6 **WHEREAS, an attempt to override vetoed Resolution No. 98-526 failed; and**

7 **WHEREAS, corrections to errors in Resolution No. 98-504 was necessary to cover all**  
8 **employees of the Nation and also to include twelve (12) Senior Community**  
9 **Services Employment Program workers.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council**  
11 **hereby approves the amendment to Resolution No. 98-504.**

12 **BE IT FURTHER RESOLVED that the amount appropriated in Resolution No. 98-**  
13 **504, (\$780,584.24) for Christmas Bonus payments is hereby increased to**  
14 **include additional employees for a final total amount of \$822,221.83.**

15 **BE IT FINALLY RESOLVED that the source of funding identified is the FY 1998 savings.**

16 **The foregoing Resolution was passed by the Tohono O'odham Council on the 15TH, day of**  
17 **DECEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,290.5 FOR;**  
18 **499.0 AGAINST; 137.5 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the**  
19 **Council by Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation,**  
20 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**  
21 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**  
22 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


