

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the \$500,000.00 Request for the Hickiwan District Home
Renovation Project - January 1 - December 31, 1999)**

RESOLUTION NO. 98-536

WHEREAS, the Hickiwan District Council had their regular meeting on October 10, 1998 to discuss District Business; and

WHEREAS, the Hickiwan District Council saw a need to request from the Tohono O'odham Nation to utilize the savings from the Gaming funds for housing repairs due to the recent bad weather that damaged homes; and

WHEREAS, other homes within the District are in dire need of minor or major repairs which has been a major concern of District members; and

WHEREAS, the \$500,000.00 allocation would be very beneficial to the Hickiwan District constituents for the proposed housing renovation project; and

WHEREAS, the funds will be placed with the Everen Securities account separate from the FY "99" Hickiwan District Budget as to be used for the purpose of the Housing Renovation Project.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does approve the \$500,000.00 request for the Hickiwan District Renovation Project which \$281,650.00 will be set aside in the Everen Account and the \$218,350.00 will be placed in the Bank of America Account to cover cost of Salaries, Fringe Benefits and Insurance.

BE IT FURTHER RESOLVED that the Hickiwan District Renovation Project would commence on January 01, 1999 and conclude on December 31, 1999.

The foregoing Resolution was passed by the Tohono O'odham Council on the 29TH, day of DECEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


