

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Certification of Selection Criteria utilized by the Districts for Selection  
of HUD-ICDBG Housing Rehabilitation Projects)**

**RESOLUTION NO. 98-539**

**WHEREAS, the Department of Housing and Urban Development guidelines require selection criteria for identifying those families most in need of housing who will receive housing renovations and wastewater facilities through the HUD ICDBG grant program; and**

**WHEREAS, the Districts participating in the ICDBG grant program (of the 11 Districts which comprise the Tohono O'odham Nation) defined their selection criteria on the basis of: those homes that are the neediest, with neediness defined as households whose income is low and very low, followed by the next ranking selection criteria, that being the household is in a great state of disrepair and the household is living in overcrowded living conditions; and**

**WHEREAS, District Councils consult with their own Housing Committees and review the applicant list of the Tohono O'odham Housing Authority; and**

**WHEREAS, the Tohono O'odham Nation's Planning and Economic Development Department undertook a survey and cost estimate for each of the proposed home renovations using a professional architect to determine cost and suitability for rehabilitation and a project specialist to collect the demographic information.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby adopts the selection criteria for the projects approved for the HUD ICDBG grant program for submission to HUD for purposes of this amendment.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 29TH day of DECEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,927,0 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
