the current positions of Planners to a Planner Supervisor and a
Grantwriter Supervisor through Human Resources; and**

**WHEREAS, the Chairman has reviewed and approved the requested reclassifications;
and**

**WHEREAS, the Planning and Economic Development Office is requesting budget
modification number 1 to supplement the increased salaries of the two
reclassified positions; and**

**WHEREAS, the budget modification has gone before the committees of Commerce and
Budget & Finance for review and approval; and**

**WHEREAS, the fiscal year budget for the Department has sufficient funds to cover the
requested reclassifications.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council
approves the Planning & Economic Development budget modification
request.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 29TH day of
DECEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,766.0 FOR;
80.5 AGAINST; 80.5 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the
Council by Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation,
adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


