3 **BE IT FURTHER RESOLVED** that the Chairman and other appropriate
4 **officers of the Tohono O'odham Nation reduce this final determination in**
5 **writing regarding each of the foregoing applications for enrollment in**
6 **accordance with Section 3(c) of Article III of the Enrollment Ordinance;**
7 **give notice of this Council's determination in accordance with Section 4**
8 **of Article III of the Enrollment Ordinance; and place the names of each**
9 **applicant upon the membership roll of the Tohono O'odham Nation in**
10 **accordance with Article V of the Enrollment Ordinance.**


11 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the**
12 **04TH. day of JANUARY, 1999 at a meeting at which a quorum was present with a vote of**
13 **1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [0] ABSENT, pursuant to the powers**
14 **vested in the Council by Section 1 of Article II and Section 1(h) of Article VI of the**
15 **Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on**
16 **January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
17 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.**
18 **984).**




