

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Accepting Certification of Eligible Members and Authorizing the Initial  
Expenditure of Funds for Per Capita Payments under the Initiative)**

**RESOLUTION NO. 99-006**

1   **WHEREAS, on June 28, 1997 the voters of the Tohono O'odham Nation (the "Nation")**  
2                   **approved Initiative No. IN-01-97 (the "Initiative"); and**

3   **WHEREAS, the Initiative authorized funding from Gaming Revenues for several measures,**  
4                   **including a one-time per capita distribution of \$2,000 to each member of the**  
5                   **Nation enrolled on June 28, 1997 (the "Initial Per Capita Distribution"); and**

6   **WHEREAS, pursuant to Resolution 97-451, the Legislative Council adopted an Initiative**  
7                   **Funding and Implementation Plan (the "FIP") which authorized the**  
8                   **establishment of set-aside accounts for the Initial Per Capita Distribution and**  
9                   **other Initiative measures, and set certain conditions on the expenditure of funds**  
10                  **from such accounts; and**

11   **WHEREAS, by Resolution 97-478, the Legislative Council approved the transfer of funds from**  
12                  **the Desert Diamond Savings Account to certain designated set-aside accounts**  
13                  **established at Bank of America Arizona, including the sum of \$41.5 million to set-**  
14                  **aside account no. 3030425-1067524 for the Initial Per Capita Distribution (the**  
15                  **"Per Capita Account"); and**

16   **WHEREAS, three of the conditions to expenditure of the Per Capita Account specified in the**  
17                  **FIP are (1) approval by the Secretary of the Interior of a per capita distribution**  
18                  **plan (the "Revenue Allocation Plan") pursuant to the requirements of the Indian**  
19                  **Gaming Regulatory Act, 25 U.S.C. § 2710 (b) (3); (2) acceptance by the Legislative**  
20                  **Council of a Certification of Eligible Members submitted by the Enrollment Office**  
21                  **and based upon receipt of a properly completed and filed Certificate of Eligibility**  
22                  **Verification for Per Capita Payment for each member; and (3) as to each Minor**  
23                  **Eligible Member, establishment of a restricted account at Bank of America for**  
24                  **deposit of such member's per capita payment; and**

25   **WHEREAS, pursuant to Resolution 97-452, the Legislative Council adopted a Revenue**

1           Allocation Plan and caused the Plan to be submitted for approval by the Phoenix  
2           Area Office of the Bureau of Indian Affairs in accordance with authority delegated  
3           to the Area Office by the Secretary of the Interior; and

4   **WHEREAS**, by letter dated December 18, 1997, the Area Office approved the Revenue  
5           Allocation Plan with respect to the Initial Per Capita Distribution and  
6           disapproved the Plan with respect to the Biennial Per Capita Payments; and

7   **WHEREAS**, an agreement with Bank of America has not yet been finalized for the  
8           establishment of the restricted accounts which is required as a condition to  
9           disbursement of the Initial Per Capita Distribution to such accounts for Minor  
10          Eligible Members; and

11   **WHEREAS**, pursuant to Resolution Nos. 97-525, 98-010, 98-037, 98-084, 98-192, 98-207, 98-  
12          278, 98-316, 98-360, 98-431, 98-478, and 98-505 the Legislative Council accepted  
13          and approved Certifications of Eligible Members for the Initial Per Capita  
14          Distribution, and disbursements have been made to such members; and

15   **WHEREAS**, the Enrollment Office has filed with the Legislative Council a Certification of  
16          Eligible Members listing 49 adult members who are eligible for receipt of the  
17          Initial Per Capita Distribution; and

18   **WHEREAS**, all conditions under the laws of the United States and the Nation have been  
19          satisfied to permit the disbursement of the Initial Per Capita Distribution to the  
20          members listed in the Certification of Eligible members.

21   **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 22                   1.   The Tohono O'odham Legislative Council hereby accepts and approves the  
23                   Certification of Eligible Members, in the form attached hereto.
- 24                   2.   The Legislative Council authorizes (a) the transfer of the sum of \$98,000  
25                   from the Per Capita Account to the special checking account no. 252-350-  
26                   324 established at Bank of America Arizona (the "Per Capita Checking

1 Account"); and (b) upon the joint signature of the Chairman and Vice  
2 Chairman of the Nation, issuance of a check on the Per Capita Checking  
3 Account in the amount of (i) \$2,000 to each Eligible Member residing in  
4 the United States and listed in the attached Certification of Eligible  
5 Members and (ii) \$1,400 to each Eligible Member residing outside the  
6 United States and listed in the attached Certification, with the balance of  
7 \$600 withheld and remitted to the Internal Revenue Service pursuant to  
8 the requirements of federal law.

9 3. The Chairman of the Nation is authorized to execute such other  
10 documents as may be necessary to implement this Resolution.

11 The foregoing Resolution was passed by the Tohono O'odham Council on the 04TH day of  
12 JANUARY, 1999 at a meeting at which a quorum was present with a vote of 1,856.0 FOR; 71.0  
13 AGAINST; -0- NOT VOTING; and [0] ABSENT, pursuant to the powers vested in the Council  
14 by Section 1(d)(1), (2) & (3) of Article VI of the Constitution of the Tohono O'odham Nation,  
15 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting  
16 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to  
17 Section 16 of the Act of June 18, 1934 (48 Stat. 984).
