1 **WHEREAS, the Schuk Toak District Council did convene in a meeting held on**  
2 **December 14, 1998 at which a quorum was present; and**

3 **WHEREAS, the Schuk Toak District Council by Resolution #ST-12-14-98-78 did**  
4 **approve to carry over funds in the amount of \$44,830.67 from the FY-98**  
5 **budget to FY-99; and**


6 **WHEREAS, the carry over funds will be utilized accordingly as approved by Schuk**  
7 **Toak District Council Resolution #ST-10-22-98-65 and Resolution #ST-11-**  
8 **04-98-69.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does**  
10 **hereby approve the FY-99 Schuk Toak District budget modification #1 to**  
11 **carry over \$44,830.67 from the FY-98 budget to be spent accordingly.**

12 **BE IT FURTHER RESOLVED that the Schuk Toak District FY-99 total budget as approved**  
13 **with the modification is in the amount of \$602,702.24 and that**  
14 **modifications to said budget can be made as necessary.**

16 **The foregoing Resolution was passed by the Tohono O'odham Council on the 07TH day of**  
17 **JANUARY, 1999 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0-**  
18 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council**  
19 **by Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**  
20 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**  
21 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**  
22 **the Act of June 18, 1934 (48 Stat. 984).**

**Resolution No. ST-12-14-98-78**

**WHEREAS;** the Schuk Toak District Council did convene in a meeting held on December 14, 1998 at which a quorum was present; and

**WHEREAS;** the Schuk Toak District Council by Resolution # ST-10-22-98-65 did approve \$25,000 under line item 9060-Professional Services to hire an appraiser to work for the District on three right-of-way projects; and

**WHEREAS;** by Resolution #ST-11-04-98-69 the Schuk Toak District Council did also approve under line item 9611- Emergency Other \$19,830.67 for the Field Nursing Home Project to pay for labor and materials for bathroom repairs; and

**WHEREAS;** both of the projects are not going to be completed in FY-98; and


