## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Approving Water Permit for Granite Construction Company for Road Construction on Highway 86)

RESOLUTION NO. 99-024

1	WHEREAS,	Granite Construction Company has contracted with the Arizona
2		Department of Transportation ("ADOT") to perform road construction and
3		repair on State Route 86 under a project entitled ADOT Road Construction
4		Project No. AC-STP-056-1(10)P (Why - Nine Mile Peak); and
5	WHEREAS,	Granite Construction Company has requested use of non-potable water
6		from an existing well in Pisinemo District called Roads Well No. 1, and has
7		entered into an agreement with Pisinemo District and the Pisinemo
8		Development Authority for withdrawal and use of water from the well; and
9	WHEREAS,	Article XVII of the Constitution of the Tohono O'odham Nation, entitled
10		Water Policy, gives to the Tohono O'odham Nation through its Legislative
11		Council, rather than to the districts, the authority to regulate water use
12		and to issue water use permits; and
13	WHEREAS,	the Tohono O'odham Legislative Council agrees to grant a water permit to
14		Granite Construction Company for use of water from Roads Well No. 1 in
15		Pisinemo District for road construction purposes, to be paid for at the rate
16		of 40 cents (\$0.40) per 1000 gallons to be paid to the Nation and to be
17		allocated 55% to the Tohono O'odham Nation and 45% to Pisinemo District,
18		which water withdrawal and use will be monitored by Pisinemo District;
19		and
20	WHEREAS,	the attached Water Permit has been reviewed by the Water Resources
21		Committee and is recommended for approval by the Legislative Council.
22	NOW, THER	EFORE, BE IT RESOLVED that the "Water Permit for Non-Potable Water,
23		Pisinemo District, Tohono O'odham Nation" is hereby approved by the
24		Tohono O'odham Legislative Council in the form attached hereto, and the

4	October 6, 1998 is hereby rescinded.
