

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appropriating \$25,000.00 To Support Inter Tribal Council of Arizona (ITCA)
Renovation of the El Encanto Building)**

RESOLUTION NO. 99-026

1 **WHEREAS, the Tohono O'odham Nation is a member of the Inter Tribal Council of**
2 **Arizona, which provides services to the 21 Tribes of Arizona; and**

3 **WHEREAS, on November 7,1996 the Inter Tribal Council of Arizona purchased El**
4 **Encanto Building for a sum of \$1,070,000.00 to better serve the tribes of**
5 **Arizona; and**

6 **WHEREAS, the Inter Tribal Council of Arizona needs further financial assistance from**
7 **member Tribes to renovate the El Encanto Building; and**

8 **WHEREAS, the Budget and Finance Committee has reviewed this request and**
9 **recommends for approval.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council of**
11 **the Tohono O'odham Nation hereby appropriates \$25,000.00 for the ITCA**
12 **Renovation of the El Encanto Building.**

13 **BE IT FURTHER RESOLVED that the sum of \$25,000.00 be appropriated from the FY**
14 **1998 identified savings.**

16 **The foregoing Resolution was passed by the Tohono O'odham Council on the 07TH day of**
17 **JANUARY, 1999 at a meeting at which a quorum was present with a vote of 1,315.0 FOR; -0-**
18 **AGAINST; 612.0 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the**
19 **Council by Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation,**
20 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
21 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
22 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
