15		adoption should be rejected, the Council shall hold a hearing concerning
16		the applicant's eligibility for enrollment or adoption; and
17	WHEREAS,	the Enrollment Committee requested that the Council schedule 20 hearings
18		for final determination of eligibility for enrollment or adoption on January
19		20, 1999 and January 21, 1999 by Resolution No. <u>98-480;</u> and
