

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Resolution No. 98-480)**

**RESOLUTION NO. 99-030**

1   **WHEREAS, Article II § 2 (A) (1) of ORDINANCE NO. 5-81 as amended ( the Enrollment**  
2                   **Ordinance) requires that the Enrollment Committee receive and review all**  
3                   **membership applications for enrollment in the Nation and make**  
4                   **recommendations to the Council whether such applications should be**  
5                   **approved or rejected; and**

6   **WHEREAS, Article II § 2 (A) (2) of the Enrollment Ordinance requires that the**  
7                   **Enrollment Committee receive and review all applications for adoption into**  
8                   **membership of the Nation and make recommendations to the Council**  
9                   **whether such applications should be approved or rejected; and**

10   **WHEREAS, the Enrollment Committee has reviewed applications for enrollment or**  
11                   **adoption and is recommending to the Council that some of such**  
12                   **applications be rejected; and**

13   **WHEREAS, Article VIII § 1 (B) of the Enrollment Ordinance requires that before**  
14                   **making a final determination that an application for enrollment or**  
15                   **adoption should be rejected, the Council shall hold a hearing concerning**  
16                   **the applicant's eligibility for enrollment or adoption; and**

17   **WHEREAS, the Enrollment Committee requested that the Council schedule 20 hearings**  
18                   **for final determination of eligibility for enrollment or adoption on January**  
19                   **20, 1999 and January 21, 1999 by Resolution No. 98-480; and**

20   **WHEREAS, the Legislative Council did schedule eight hearings for Final Determination**  
21                   **of Eligibility for Enrollment or Adoption for January 20, 1999 at the Council**  
22                   **Chambers in Sells, Arizona by Resolution No. 98-480; and**

23   **WHEREAS, the Legislative Council did schedule twelve hearings for Final**  
24                   **Determination of Eligibility for Enrollment or Adoption for January 21,**  
25                   **1999 at the Council Chambers in Sells, Arizona by Resolution No. 98-480;**

**WHEREAS, such Rules require that such hearings for Final Determination of Eligibility for Enrollment or Adoption conform to the requirements of such Rules.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 1. Resolution No. 98-480 is amended to conform to the Rules of Procedure For Hearings on Final Determination of Eligibility for Enrollment or Adoption.**
- 2. Accordingly, the January 20, 1999 and January 21, 1999 hearings for Final Determination of Eligibility for Enrollment or Adoption are canceled and continued in accordance with such Rules of Procedure.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 19TH day of JANUARY, 1999 at a meeting at which a quorum was present with a vote of 1,656.5 FOR; 80.5 AGAINST; -0- NOT VOTING; and 190.0 [09] ABSENT, pursuant to the powers vested in the Council by Section 1(h) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**

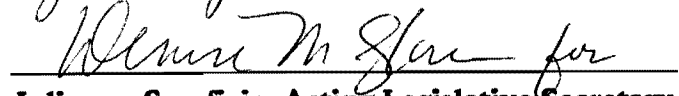
