

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Tohono O'odham Nation Education Department Vocational  
Rehabilitation Budget beginning October 1, 1998 through September 30, 1999 as  
funded by U.S. Department of Education, Section 121 Grant No. H250G980011)**

**RESOLUTION NO. 99-031**

1 **WHEREAS, the Tohono O'odham Legislative Council previously supported the Nation's**  
2 **submittal of a grant proposal to establish a vocational rehabilitation**  
3 **program under Resolution No. 98-202; and**

4 **WHEREAS, the Tohono O'odham Nation has received a grant award notification**  
5 **number #H250G980011 for a current funding allocation in the amount of**  
6 **\$211,431.00 for the period of October 1, 1998 through September 30, 1999;**  
7 **and**

8 **WHEREAS, the grant award also indicates continued funding for a total of five years at**  
9 **an amount of \$2,047,416.00 ending September 30, 2003.**

10 **NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative**  
11 **Council hereby approves the Tohono O'odham Nation Education**  
12 **Department Vocational Rehabilitation Budget in the amount of**  
13 **\$211,431.00.**

14 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the**  
15 **Tohono O'odham Nation's Officials, to wit: the Chairman and any**  
16 **designated official are hereby authorized to execute the grant award,**  
17 **provided however that any amendments affecting the funding or funding**  
18 **levels of this grant shall be submitted for further approval.**

19 **The foregoing Resolution was passed by the Tohono O'odham Council on the 19TH. day of**  
20 **JANUARY, 1999 at a meeting at which a quorum was present with a vote of 1,737.0 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and 190.0 [10] ABSENT, pursuant to the powers vested in the**  
22 **Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation,**  
23 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**  
24 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**  
25 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


