

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of the Gu-Vo District Supplemental FY'99 Budget)**

RESOLUTION NO. 99-033

1 WHEREAS, the Gu-Vo District Governing Council did meet on Wednesday, January 13,  
2 1999 and did discuss the proposed FY'99 Supplemental budget; and

3 WHEREAS, the Gu-Vo District Governing Council feels that this supplemental funding  
4 from the Tohono O'odham Nation's Gaming Revenue Savings in the  
5 amount of Five Hundred Thousand Dollars (\$500,000.00) is a necessity for  
6 the Gu-Vo District.

7 NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council  
8 hereby approves the Proposed FY'99 Budget from the supplemental funds  
9 in the amount of \$500,000.00.


10 BE IT FURTHER RESOLVED, that the budget will be broken down in the following  
11 allocations:

12	District Administration:	\$420,000.00
13	Gu-Vo Community:	\$ 20,000.00
14	Ali Chugk Community:	\$ 20,000.00
15	Pia Oik Community:	\$ 20,000.00
16	Kukatch Community:	\$ 20,000.00
17	GRAND TOTAL	\$500,000.00

19 BE IT FINALLY RESOLVED THAT the expenditure period for these funds is January  
20 01, 1999 through December 31, 1999.

21 The foregoing Resolution was passed by the Tohono O'odham Council on the 19TH day of  
22 JANUARY, 1999 at a meeting at which a quorum was present with a vote of 1,187.5 FOR;  
23 739.5 AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the  
24 Council by Section 1(d)(2) & (3) of Article VI of the Constitution of the Tohono O'odham  
25 Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the  
26 Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant  
27 to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
