10	WHEREAS, in	n furtherance of Resolution No. 98-020, representatives of the Nation had
11	n	umerous meetings and discussions with representatives of the State to work
12	O'	ut the terms of a settlement agreement; and
13	WHEREAS, ti	he Commerce Committee and the Nation's Chairman recommend settlement
14	O:	f the lawsuit in accordance with the terms of the settlement agreement which
15	is	attached hereto and incorporated herein by this reference.
16	NOW, THERE	FORE, BE IT RESOLVED THAT:
17	1.	The settlement agreement in the form attached hereto is hereby approved.
18	2.	The Nation's Chairman is authorized and directed to execute the settlement
19		agreement.
20	3.	The Nation's Office of Attorney General is authorized and directed to take all
21		reasonable and necessary steps to conclude the litigation in accordance with
22		the terms approved herein.
23	4	In connection with the Settlement Agreement, the Tohono O'odham Nation
24		has agreed to pay the sum of \$244,455 to the State of Arizona. The Gaming
25		Authority is authorized to pay that sum to the State.
