4 vested in the Council by Section 1 of Article II and Section 1(h) of Article VI of the
5 Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on
6 January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
7 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
8 984).


